In exercise of the powers conferred on him by Order No.SEC/MC-2018/W.S.02/desk 06, Dated 20/03/2018 & Order No.SEC/NP-2016/P.K.07/Ka/06 dated 07/05/2016 of the State Election Commissioner, Maharashtra. **The Collector of Pune** hereby proposes to make the following draft ordered under sub-section (1) of section 10 of the Maharashtra Municipal Council, Nagar Panchayats and Industrial Township Act, 1965 (Mah XL of 1965) to fix for the **Bhor Municipal Council**, the number of seats to be elected and the extent of the wards into which said **Bhor Municipal** area of the Municipal Council is to be divided and the wards reserved for Schedule Caste, Scheduled Tribes, Backward Class of Citizens and Women (including women belonging to the Scheduled Caste, Scheduled Tribes, Backward Class of Citizens), as the case may be, shown in the Scheduled to the Order.

2. The said draft ordered is hereby published as required by the provisions sub-section (1) of section 10 of the Maharashtra Municipal Council, Nagar Panchayats and Industrial Township Act, 1965 for the information of all the residents of the **Bhor Municipal Council** and notice is here by given that the said draft will be taken into considerations by **The Collector, Pune** from 17/04/2018.

3. All persons who desire to entertain any objection to the said draft should submit the same to **The Collector, Pune** in writing with reasons from 17/04/2018 to 24/04/2018 during office hours. Objections received there after will not be considered (the place for submitting objections – Bhor Municipal Council)

& SEC/NP-2016/PK-10/Ka-06 Dated 15/06/2016 of the State Election Commissioner, Maharashtra, read with Sub-Section (1) of Section 10 of the Maharashtra Municipal Council, Nagar Panchayats and Industrial Township Act, 1965 (Mah.XL of 1965). **I, Sourabh Rao, The Collector of Pune District,** hereby fix the number and extent of the wards into which the said Municipal area shall be divided and specify the wards in which seats shall be reserved for Schedule Castes, Scheduled Tribes and Backward Class of Citizens and Women (Including Women belonging to the Scheduled Caste, The Scheduled Tribes and Backward Class of Citizens), as the case may be, as shown in the schedule to this Order.
